

TERMS AND CONDITIONS

Liquor Service Licence

Dining Room, Dining Room/Lounge Liquor Sales with Delivery and Takeout Food Orders

Licensees must comply with all general liquor service terms and conditions, terms and conditions specific to the type of licence held, and any terms and conditions specific to the premises.

1.0 General

1.1

Dining room licensees and dining room/lounge licensees may sell beer, wine, cider and coolers for delivery or takeout in conjunction with food prepared by the licensee in the licensee's kitchen. The licensee must notify the Liquor, Gaming and Cannabis Authority (LGCA) if they choose to conduct these types of liquor sales.

1.2

Beer, wine, cider and coolers may be sold for delivery or takeout with meals only while the dining room or dining room/lounge is open and operating, unless otherwise authorized by the executive director.

1.3

The licensee may only sell liquor for delivery or takeout with food between the hours of

- a) 9.00 a.m. to 12.00 midnight; and
- b) 1.00 p.m. to 12.00 midnight on Remembrance Day.

1.4

The licensee may only deliver liquor with food between the hours of

- a) 9.00 a.m. to 12.30 a.m.; and
- b) 1.00 p.m. to 12.30 a.m. on Remembrance Day.

1.5

Liquor sold must be available for sale in the licensed premises and must be sold at the same price at which it is sold for consumption in the licensed premises.

1.6

The licensee must ensure that container pricing complies with Section 6.1 of Manitoba Regulation 61/2014.

1.7

The licensee must ensure all liquor sold for delivery or takeout is sold in its original sealed container.

1.8

The licensee must inform the purchaser of the price of the food, liquor and delivery charge at the time when the order is placed and must provide the purchaser with a receipt showing each charge listed separately.

1.9

The licensee must record all liquor and the accompanying food sold for delivery or takeout on an itemized receipt and maintain those records for a two-year period.

1.10

The licensee must ensure that only persons 18 years of age or older may place and receive an order for liquor.

1.11

All persons delivering liquor must be at least 18 years of age and have successfully completed a training course specified by the executive director.



1.12

The licensee must ensure that all persons delivering liquor sold under this section must not deliver liquor to

- a) a minor;
- b) a person who is or appears to be intoxicated;
- c) another person who is not authorized to sell liquor if the licensee knows that the other person intends to sell the liquor in contravention of the Act; or
- d) a place where liquor may not be lawfully kept or possessed.

1.13

If a liquor order is delivered to a person who appears to be a minor, the licensee or delivery person must require that person to produce one of the following types of valid identification that belongs to the person:

- a) a passport;
- b) a driver's licence;
- c) an identification card issued by Manitoba Public Insurance;
- d) a Secure Certificate of Indian Status issued by the Government of Canada;
- e) a NEXUS card;
- f) a Canadian Armed Forces identification card;
- g) a possession and acquisition licence issued under the *Firearms Act* (Canada);
- h) a Manitoba Métis Federation citizenship card;
- i) two pieces of government-issued identification, with at least one piece of identification containing a photograph of the person.

1.14

If the purchaser is unable to produce the required identification, the licensee or delivery person must not deliver liquor to that person.

1.15

Any liquor that cannot be delivered to the purchaser for any reason must be brought back to the licensee.

1.16

The licensee must ensure that liquor is transported in compliance with section 60 and section 61 of the Act.

1.17

The licensee is responsible to ensure that any person delivering liquor on behalf of the licensee complies with these terms and conditions.
